

Use FDA Guidelines to Switch to the Hanningfield Uni-Mill

Many engineers worry about changing equipment on an existing process, hence if a mill needs replacing they will return to the original manufacturer to seek a replacement.

However, many do not realise that under the FDA SUPAC guidelines this is no longer necessary, and engineers can freely switch between suppliers even once a process has been approved. Indeed, the FDA will sometimes even prefer a change of supplier if there is a cGMP benefit. This allows engineers not only to switch suppliers, but also the type of mill. Hence, the procedure of changing from a hammer mill or oscillating mill is made simple, due to the efficiency improvements.

Below is a table taken directly from the SUPAC Document, showing the typical manufacturers from whom you may wish to switch. The examples column on the right hand side shows suppliers identified by the FDA from whom you may wish to switch.
